



You'll then formalize your company name and prepare all legal documents to ensure compliance with local regulations. After that, obtain a Commercial Registration (CR) certificate and register with the Chamber of Commerce (CoC) to validate your business operations. Together, these steps build a strong legal foundation and official recognition for your company to operate and grow confidently in Saudi Arabia.

2. Compliance Registration

After obtaining your company seal, you must register with the Ministry of Labor (MoL) and GOSI to legally begin hiring employees and managing payroll. Next, register your company's address in the national database, secure a General Manager (GM) visa, and register with GAZT for tax and VAT compliance. To establish your company as a foreigner in the Kingdom, the 3 stages are broken down into 21 steps.

STAGE 1

Foundations of the Legal Entity

- Obtain a MISA Investor License
- Name Reservation
- Draft Local Articles of Association
- Commercial Registration (CR)
- Chamber of Commerce (CoC) Registration.

STAGE 2

Compliance Registration

- Obtain a Company Seal
- Register with the Ministry of Labor
- Organization for Social Issuance (GOSI)
- Register a National Address
- Issue a GM Visa
- Authority of Zakat and Tax (GAZT) and VAT Registration

STAGE 3

Company Activation

- Activate the Chamber of Commerce Account
- Obtain Health Insurance
- Get a Medical Check-up()
- Register with the Muqeem portal for streamlined visa and residence management
- Register with the Absher portal for an array of e-government services
- Register with the Qiwa portal for business services designed for SMEs
- Issuing the GM's Iqama
- Register with the Mudad Portal to manage essential municipal services for your company
- Open a Bank Account
- Harmonization
